Producer Price Inflation rises slightly to 19.51 in August 2010.

The Producer Price Index

The Producer Price Index (PPI) measures the average change over time in the prices received by domestic producers for the production of their goods and services. The PPI for Ghana reports the price indices with reference to September 2006, the base period. This release shows the producer price growth since September 2006, as well as the annual (point-to-point) and monthly inflation rates, for all industry and three major sub-sectors of industry (Mining and Quarrying, Manufacturing, and Utilities).

August 2010 Producer Inflation

In August 2010 the Price Index with reference to the base period (September 2006) was 213.90, after recording 212.33 in July 2010. This translates to a monthly change rate (i.e., the percentage change in the PPI between July 2010 and August 2010) of **0.74** percent, after -0.15 percent in July 2010 (Table 1).

The respective yearly change (i.e., the percentage change in the PPI between August 2010 and August 2009) was **19.51** percent, indicating a 0.58

percentage points higher than that for July 2010 (Table 1).

Manufacturing, the largest industrial sub-sector (with 69.75 percent share of all industry), recorded an inflation rate of 7.38 percent.

Mining and Quarrying (with 13.97 percent share of all industry) recorded inflation rate of 20.17 percent.

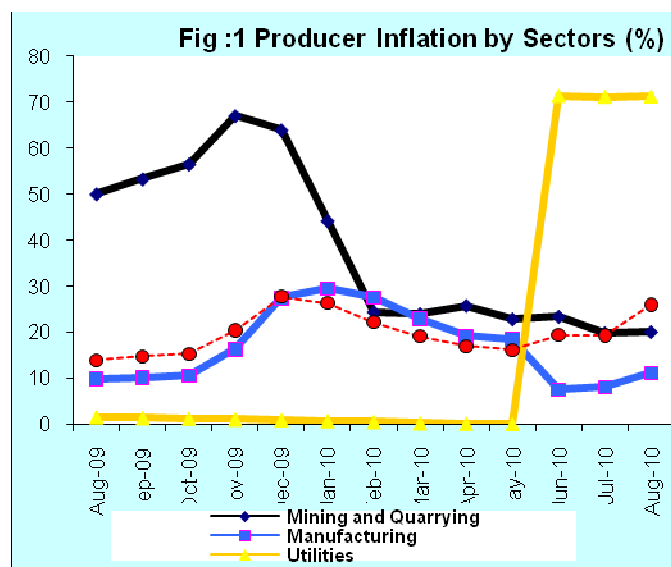
Utilities, (which includes production, transmission and distribution of electricity; collection, purification and distribution of water), recorded inflation rate of 71.14 percent.

Trends

Inflation for August 2010 was higher than the rate recorded in the same period in 2009 (19.51%). The all industry year-on-year average inflation for the first eight months of 2010 was 19.80 percent.

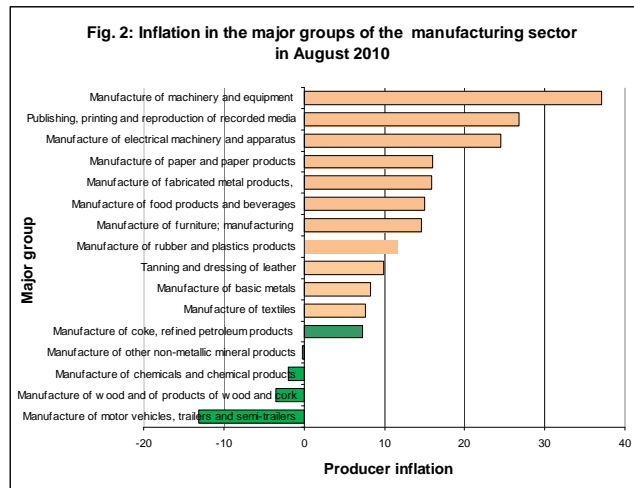
During the 13-month period (August 2009 to August 2010), the all industry recorded the highest inflation rate in December 2009 (27.71 %). The rates, however, declined from January 2010 to May 2010, before it **increased** in June 2010.

Between July 2009 and May 2010, mining and quarrying sector exhibited the highest inflation rate, except in February and May 2010 when manufacturing and utilities respectively recorded the highest. Utilities have since June 2010 recorded the highest inflation (figure 1).



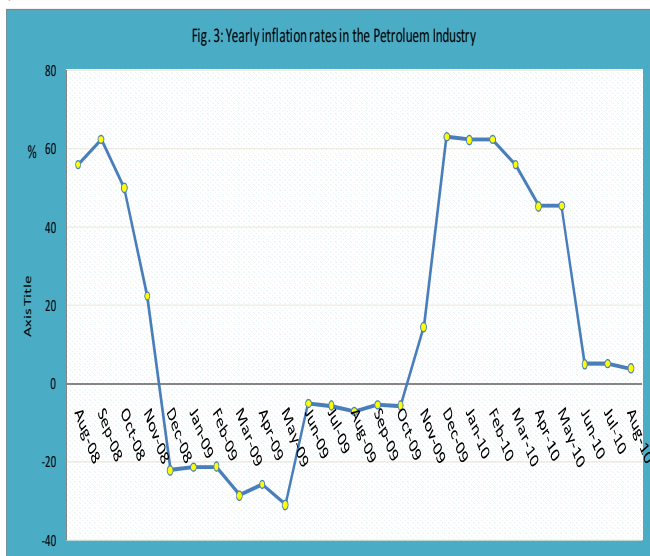
Manufacturing Sector

Eleven out of the sixteen major groups in the manufacturing sector recorded inflation rates higher than the manufacturing sector average (figure 2). Manufacture of electrical equipment recorded the highest inflation rate (49.26%) while manufacture of motor vehicles, trailers and semi-trailers, manufacture of wood and of wood product and cork, and manufacture of chemical and chemical products recorded negative inflation rates of 13.13, 12.17 and 4.85 percent respectively.



Petroleum Price Index

Between October 2009 and December 2009, producer inflation in the manufacture of petroleum products group recorded a sharp increase. Inflation in this sector stabilized for the first two months of 2010, but dropped between March and June 2010. The rate for August 2010 was lower (1.23 percentage points) than that of July 2010 (fig 3).

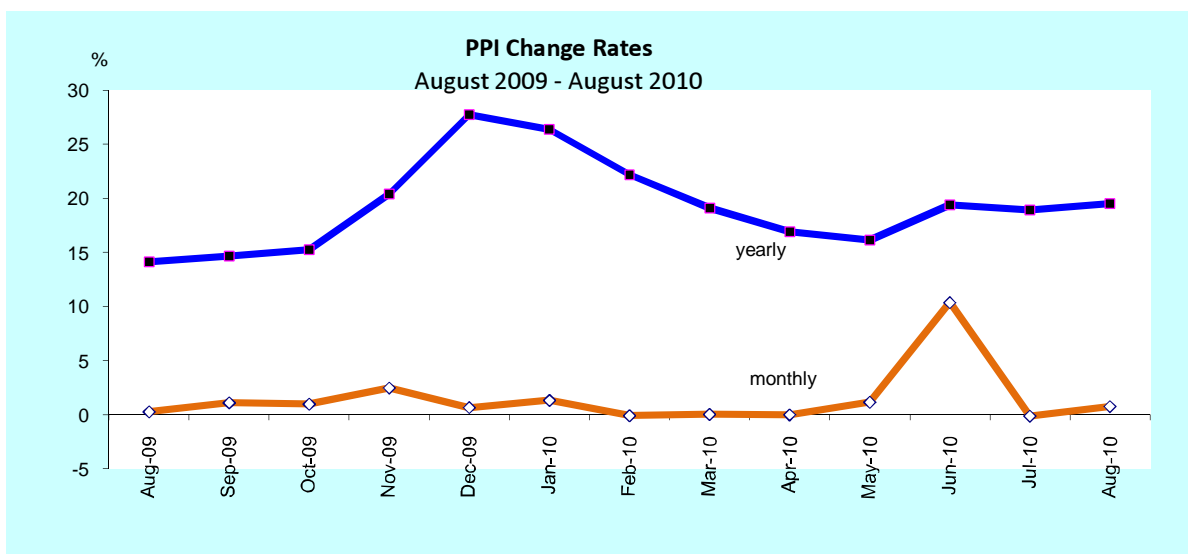
