Producer Price Inflation Decreases to 16.01 in November 2010.

The Producer Price Index

The Producer Price Index (PPI) measures the average change over time in the prices received by domestic producers for the production of their goods and services. The PPI for Ghana reports the price indices with reference to September 2006, the base period. This release shows the producer price growth since September 2006, as well as the annual (point-to-point) and monthly inflation rates, for all industry and three major sub-sectors of industry (Mining and Quarrying, Manufacturing, and Utilities).

November 2010 Producer Inflation

In November 2010 the Price Index with reference to the base period (September 2006) was 217.10, after recording 214.57 in October 2010. This translates to a monthly change rate (i.e., the percentage change in the PPI between October 2010 and November 2010) of **1.18** percent, after 1.45 percent in October 2010 (Table 1).

The respective yearly change (i.e., the percentage change in the PPI between November 2009 and November 2010) was **16.01** percent, indicating a

1.47 percentage points lower than that for October 2010 (Table 1).

Manufacturing, the largest industrial sub-sector recorded an inflation rate of 3.83 percent.

Mining and Quarrying recorded inflation rate of 20.35 percent.

Utilities, (which includes production, transmission and distribution of electricity; collection, purification and distribution of water), recorded inflation rate of 71.50 percent.

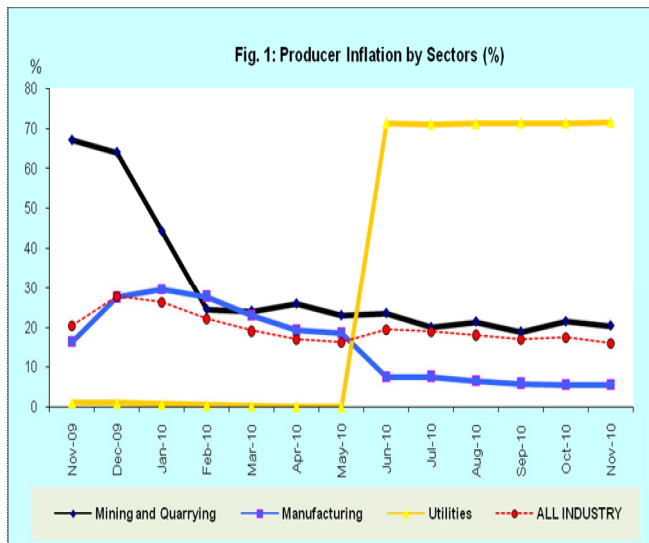

Trends

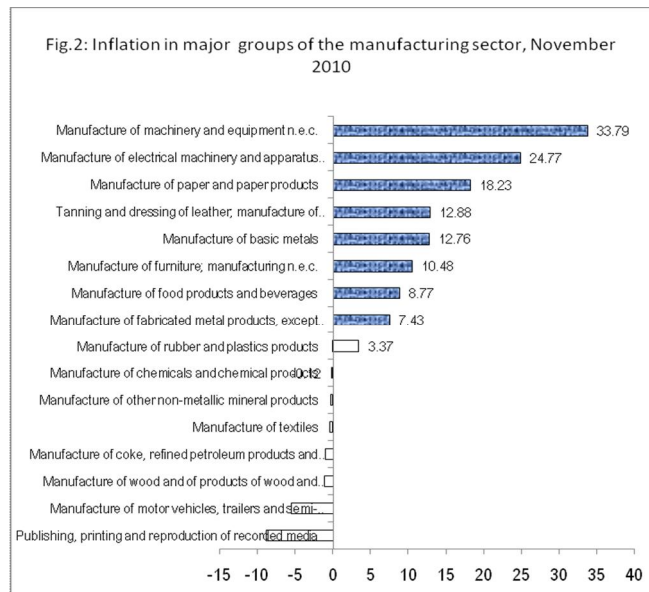
Inflation rate for November 2010 was lower than the rate recorded in the same period in 2009 (20.36%). The all industry year-on-year average inflation for the first eleven months of 2010 was 18.85 percent.

During the 12-month period (November 2009 to November 2010), the all industry recorded the highest inflation rate in December 2009 (27.71 %). Between January 2010 and May 2010, the rates declined, but increased in June 2010 and started declining steadily between July and September 2010. In October 2010 it increased slightly but decline again in November 2010.



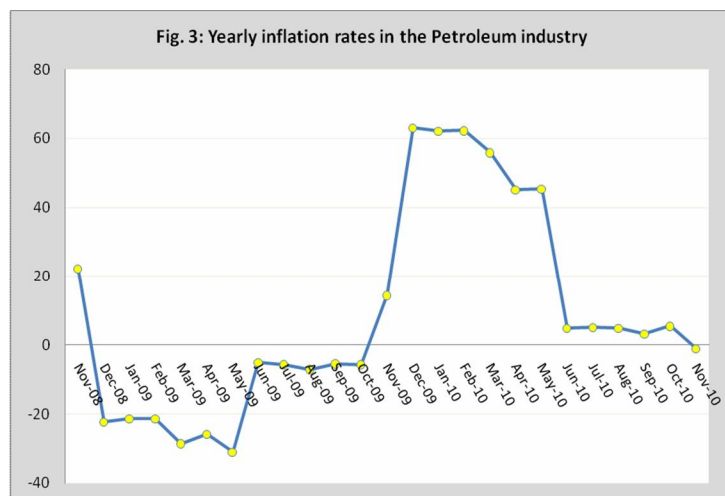
Manufacturing Sector

Eight out of the sixteen major groups in the manufacturing sector recorded inflation rates higher than the manufacturing sector average (figure 2). Manufacture of machinery and equipment recorded the highest inflation rate (33.79%) while publishing, printing and reproduction of recorded media, manufacture of motor vehicles, trailers and semi-trailers, manufacture of wood and of wood products and cork, among others recorded negative inflation rates of 8.85, 5.57, 1.11 percent respectively (figure 2).



Petroleum Price Index

Between October 2009 and December 2009, producer inflation in the manufacture of petroleum products group recorded a sharp increase. Inflation in this sector stabilized for the first two months of 2010, but dropped between March and June 2010. The rate declined in November 2010 after increasing slightly in October 2010 (fig 3).

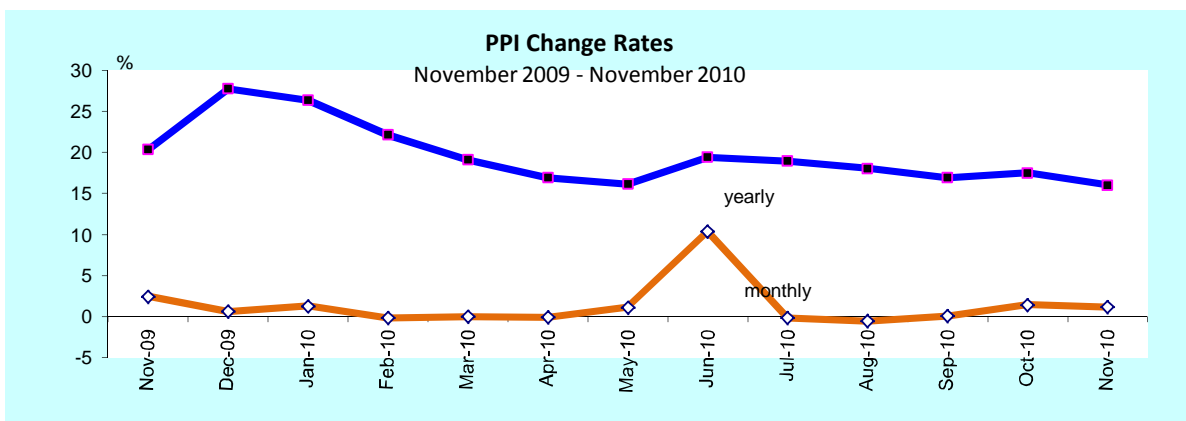
