Producer Price Inflation decreases to 23.80% in May 2011

The Producer Price Index

The Producer Price Index (PPI) measures the average change over time in the prices received by domestic producers for the production of their goods and services. The PPI for Ghana reports the price indices with reference to September 2006, the base period. This release shows the producer price growth since September 2006, as well as the annual (year-on-year) and monthly inflation rates, for all industry and three major sub-sectors of industry (Mining and Quarrying, Manufacturing, and Utilities). The current monthly data are provisional, and are subject to revision in the following month. All other data are final.

May 2011 Producer Inflation

The producer price index increased 23.80 percent year-on-year in May 2011, lower than the growth recorded in April 2011. Month-on-month, producer prices rose 0.74 percent during the month, after increasing 0.63 percent in the April (Table 1).

Mining and quarrying prices declined to 32.60 percent, from a rate of 37.07 percent in April 2011. Manufacturing which contributes more than two-thirds to total industry climbed 12.42 percent, from 12.22 percent in April, 2011. The highest year-on-year price change of 71.84 was recorded in the Utilities sector, and this has remained virtually unchanged since June 2010.

Trends

The May 2011 inflation rate was 23.80, declining by 0.49 percentage points compared to the April rate of 24.29%, the highest rate in the 12-month period.

During the 12-month period (May 2010 to May 2011), the all industry recorded the highest inflation rate in April 2011. Between May 2010 and June 2010, the rates increased slightly. Thereafter, the rates were quite stable until November 2010. From

December 2010 to May 2011, the rates have been rising steadily (Fig. 1).

Manufacturing Sector

Seven out of the sixteen major groups in the manufacturing sector recorded inflation rates higher than the manufacturing sector average of 12.42 percent. Manufacture of paper and paper products recorded the highest inflation rate (36.41%), whilst manufacture of fabricated metal recorded a negative change rate (Fig. 2).

Petroleum Price Index

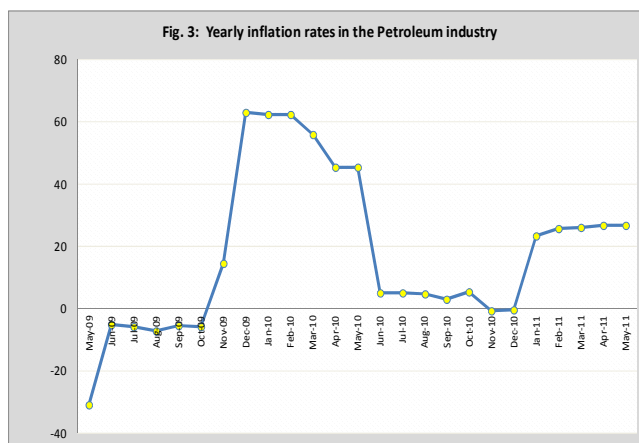
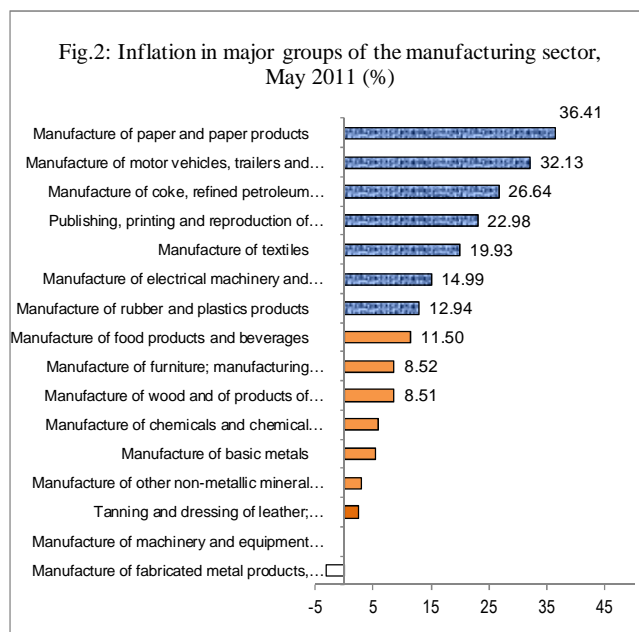
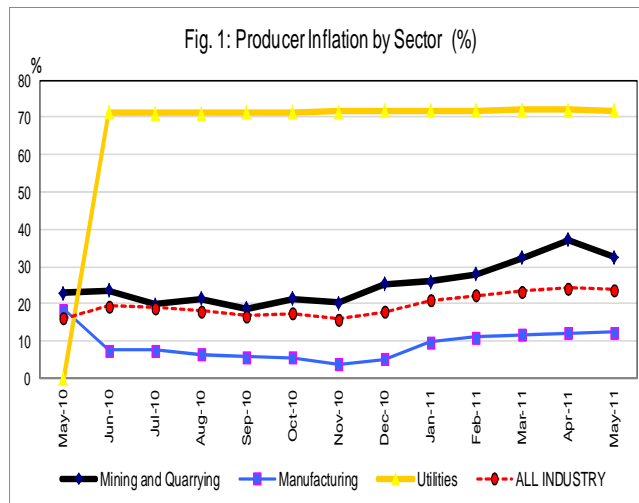
Between October 2009 and December 2009, producer inflation in the manufacture of petroleum products recorded a sharp increase. Inflation in this industry stabilized for the first two months of 2010, but dropped between March and June 2010. The rate declined in November 2010 after increasing slightly in October 2010. In January 2011 inflation in the petroleum industry jumped, but since February 2011 the rate has remained stable recording 26.64% in May 2011 (Fig 3).

Overview

The year-on-year inflation from the producer’s perspective for all industry for May 2011 is 23.80%; and the monthly rate is 0.74 %.

Utility recorded the highest year-on-year inflation (71.84%), followed by mining and quarrying (32.60%) and manufacturing (12.42%).

Mining and quarrying recorded the highest monthly change of 1.36%, followed by manufacturing (0.62%); and utilities (0.00)

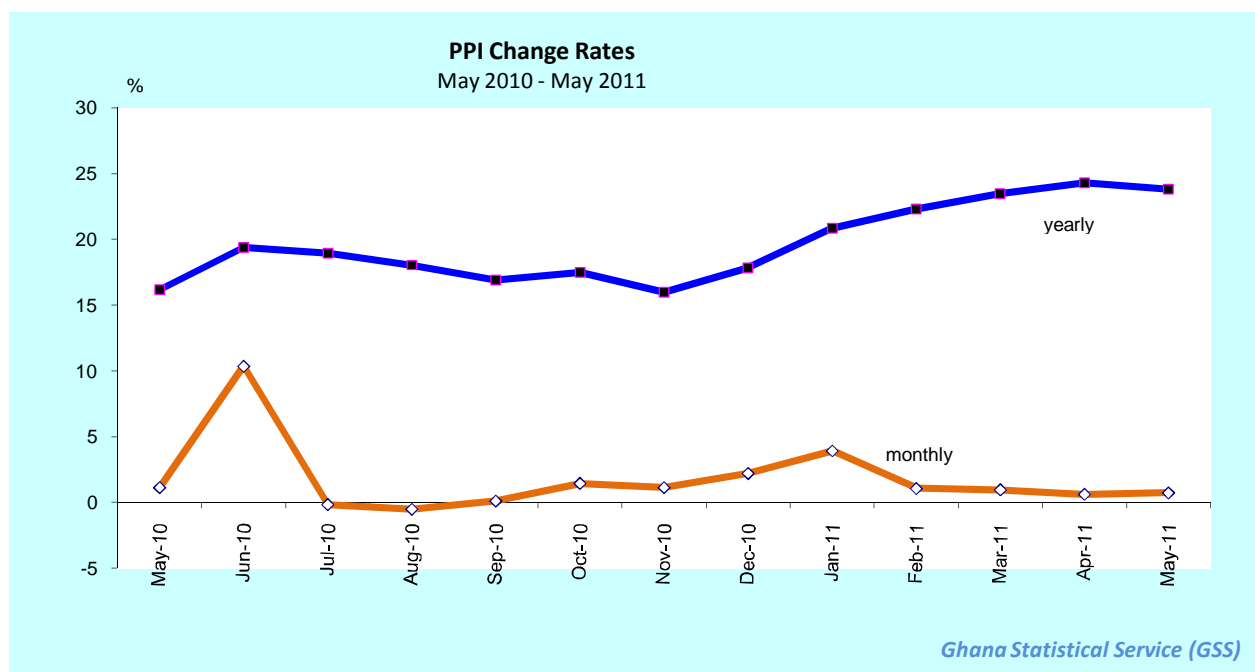
