## Producer Price Inflation Increases to 17.28% in November 2011

### The Producer Price Index

The Producer Price Index (PPI) measures the average change over time in the prices received by domestic producers for the production of their goods and services. The PPI for Ghana reports the price indices with reference to September 2006, the base period. This release shows the producer price changes since September 2006, as well as the annual (year-on-year) and monthly inflation rates, for all industry and three major sub-sectors of industry (Mining and Quarrying, Manufacturing, and Utilities) for the last twelve months. The figures for the month of November 2011 are provisional, and are subject to revision in the release when additional data would be available. All other indicators are final.

### November 2011 Producer Inflation

The producer price index increased 17.28 percent between November 2010 and November 2011 (year-on-year), representing a slight increase in producer inflation of 0.88 percentage points relative to the rate in October 2011 (16.40%). The month-on-month producer prices increased 1.90 percent, after recording a slight decrease (-1.25%) in October 2011 (Table 1).

Producer price inflation in the mining and quarrying sector increased by 4.92 percentage points over the October 2011 rate (31.45%) to record 36.36 percent. Manufacturing, which constitutes more than two-thirds of total industry, increased marginally to 16.50 percent, from a rate of 16.24 percent in October 2011. The lowest year-on-year price change of 7.71 was recorded in the Utilities sector (Table 2) for the month of November 2011.

### Trends

The November 2011 inflation rate was 17.28, was 0.88 percentage point higher than the October rate.

During the 12-month period (November 2010 to November 2011), all industry recorded the highest producer inflation rate of 24.29% in April 2011. The inflation rate rose steadily from November 2010 peaking in April 2011. It declined between May and June, and resumed the increase until September 2011 (19.59 %). The rate declined in October 2011

and increased slightly in November 2011, recording a change rate of 17.28% percent. The rate remains lower than those from January to May 2011, which ranged from 20.85 and 24.29 percent.

### Manufacturing Sector

During the month of November 2011, six out of the sixteen major groups in the manufacturing sector recorded inflation rates higher than the sector average of 16.50 percent (Fig. 2). Manufacture of textiles recorded the highest inflation rate (40.12%), whilst tanning and dressing of leather and manufacture of hand luggage recorded the lowest, and the only negative rate (-2.59%).

### Petroleum Price Index

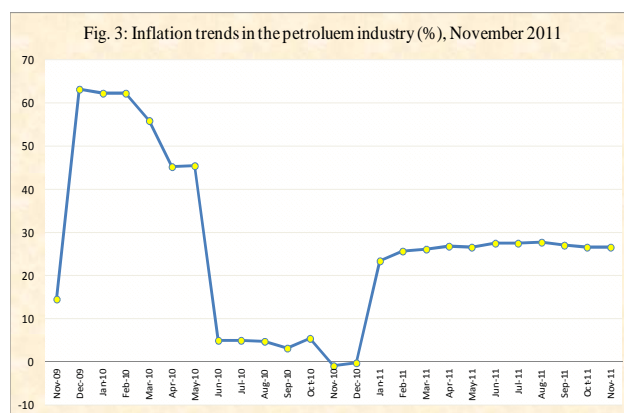
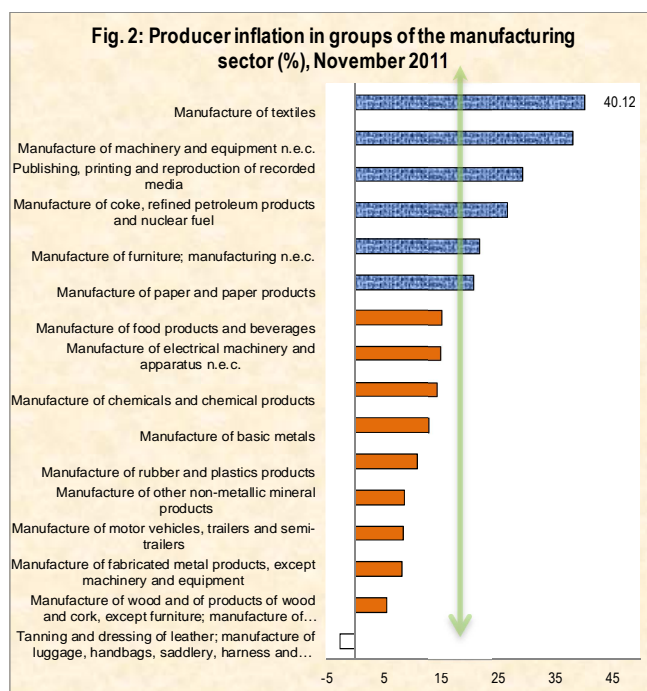
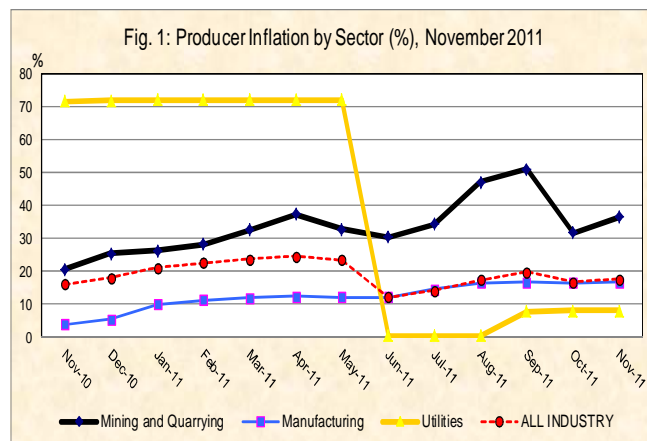
Over the last two years, inflation in the petroleum industry subgroup recorded four major significant changes in December 2009, April 2010, June 2010, and January 2011. The price increase in January 2011, resulted in a sharp rise in inflation for this subgroup in January 2011 (23.39 %), but has remained stable since then, recording 26.46 percent in November 2011 (Fig 3).

### Highlights

The year-on-year producer inflation for all industry in November 2011 is 17.28%; the monthly rate is 1.90 percent.

Mining and quarrying recorded the highest year-on-year rate of 36.36%, followed by manufacturing (16.50%). Utilities recorded the lowest rate of 7.71%.

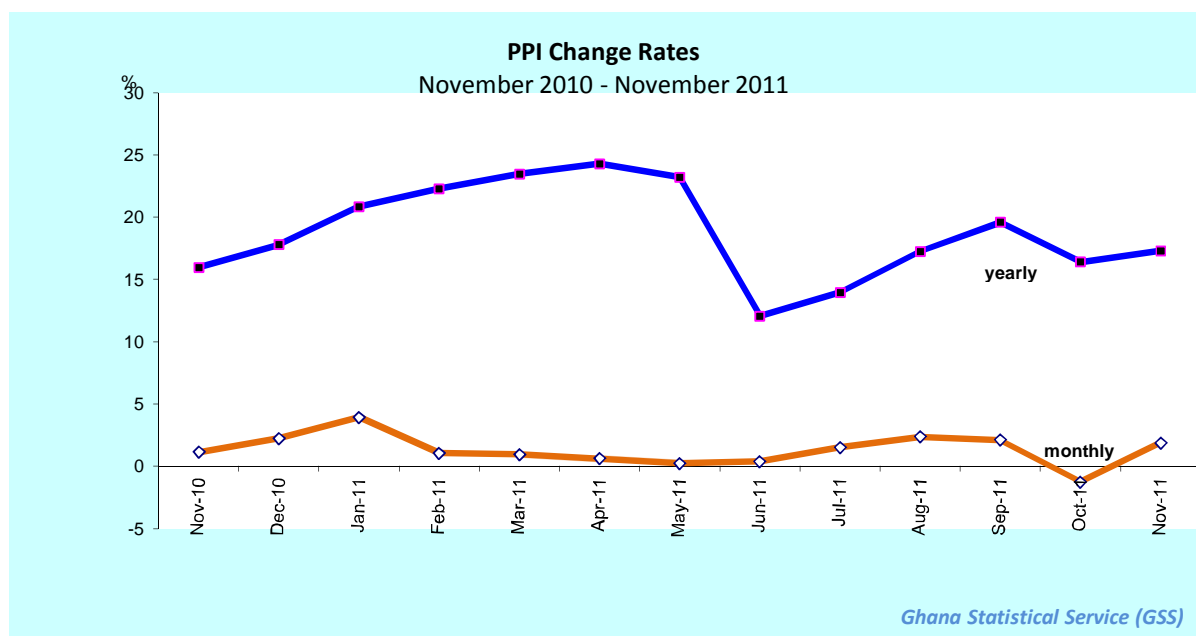
Between October and November 2011, mining and quarrying recorded the highest monthly change of 7.08 %, followed by manufacturing (1.23%). There was no change in inflation rate in the utilities sector (0.00%).
